RELEASE FROM RESPONSIBILITY, WAIVER OF LIABILITY AND ASSUMPTION OF RISK FOR PARTICIPATION IN A DANGEROUS ACTIVITY

FOR AND IN CONSIDERATION of permitting THE UNDERSIGNED to participate with the CALIFORNIA PRECISION RIFLE CLUB INC. for the purposes of firearms use, shooting of firearms, observing the use of firearms, or any and all other purposes, THE UNDERSIGNED, for himself/herself, his/her heirs, executors, administrators and assigns:

1. Hereby voluntarily releases, discharges, waives and relinquishes any and all actions or causes of actions for personal injury, property damage or wrongful death occurring to the undersigned arising as a result of engaging in or being present at activities sponsored by the CALIFORNIA PRECISION RIFLE CLUB INC.

2. Hereby covenants not to sue and voluntarily releases, waives discharges and relinquishes any action or causes of action, aforesaid, which may hereafter arise for himself/herself and for his/her estate, and agrees that under no circumstances will he/she or his/her heirs, executors, administrators and assigns prosecute or present any claim for personal injury, property damage or wrongful death against the CALIFORNIA PRECISION RIFLE CLUB INC., or any of its officers, agents, servants or employees for any said causes of action, whether the same shall arise by the negligence of any of said persons or otherwise. IT IS THE INTENTION OF THE UNDERSIGNED BY THIS INSTRUMENT, TO EXEMPT AND RELIEVE THE CALIFORNIA PRECISION RIFLE CLUB INC., OR ANY OF ITS OFFICERS, AGENTS, SERVANTS OR EMPLOYEES; INCLUDING VOLUNTEERS, FROM LIABILITY FOR PERSONAL INJURY, PROPERTY DAMAGE OR WRONGFUL DEATH CAUSED BY NEGLIGENCE.
